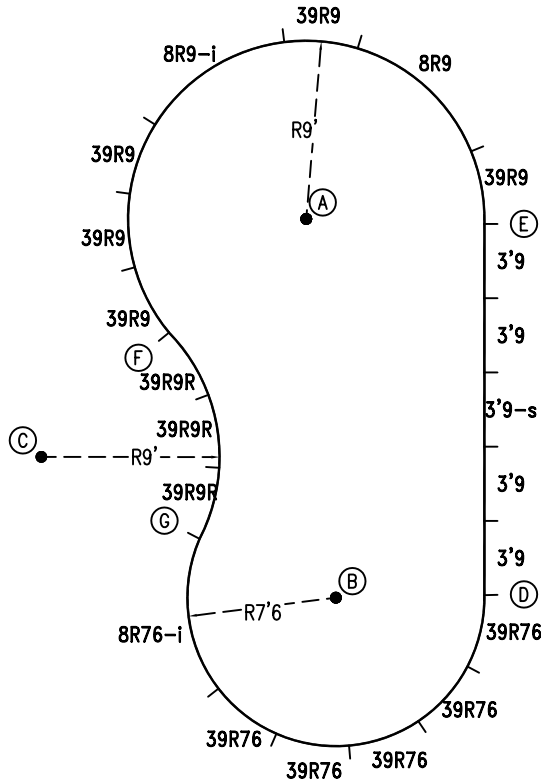

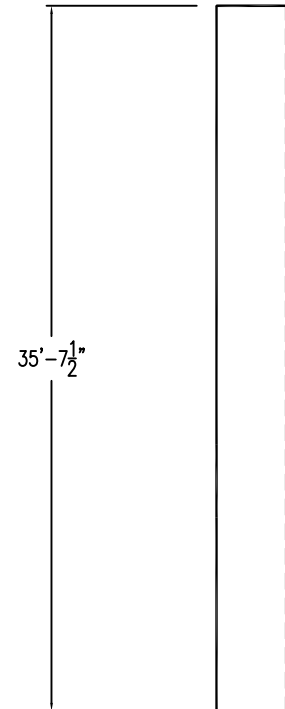

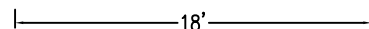


6" WATER LINE

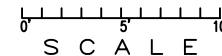

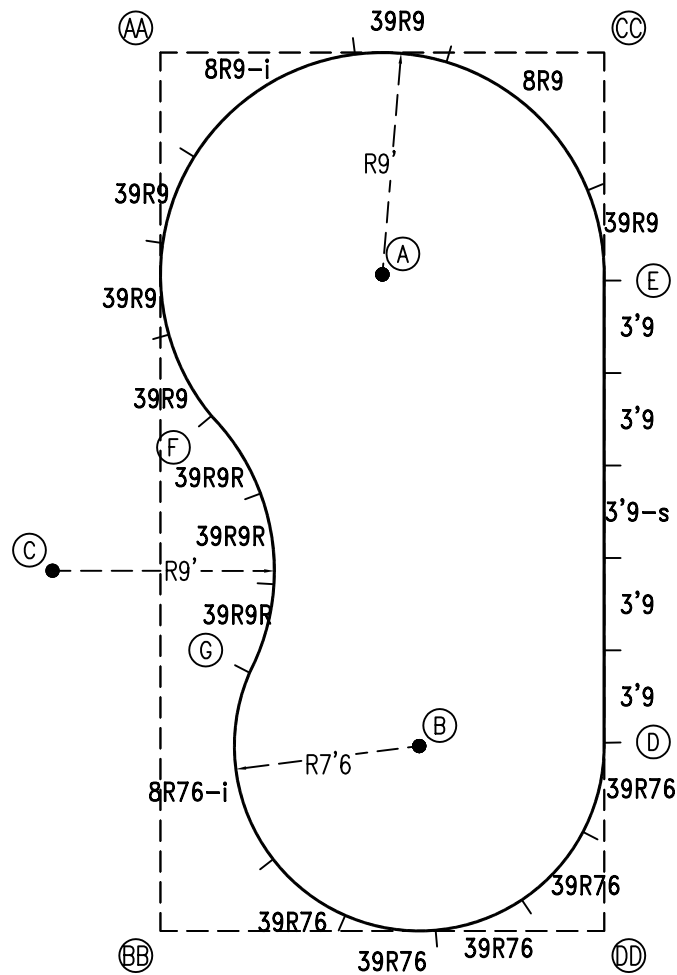

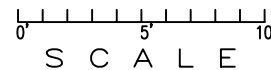
