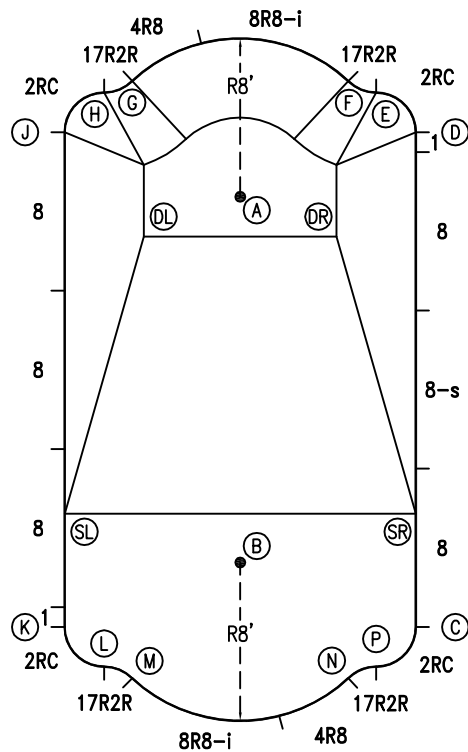

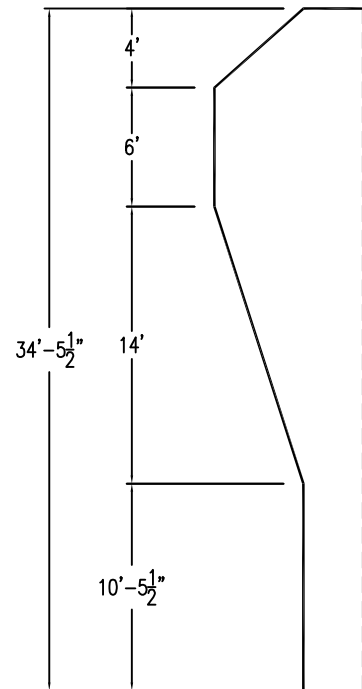

6" WATER LINE

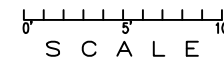

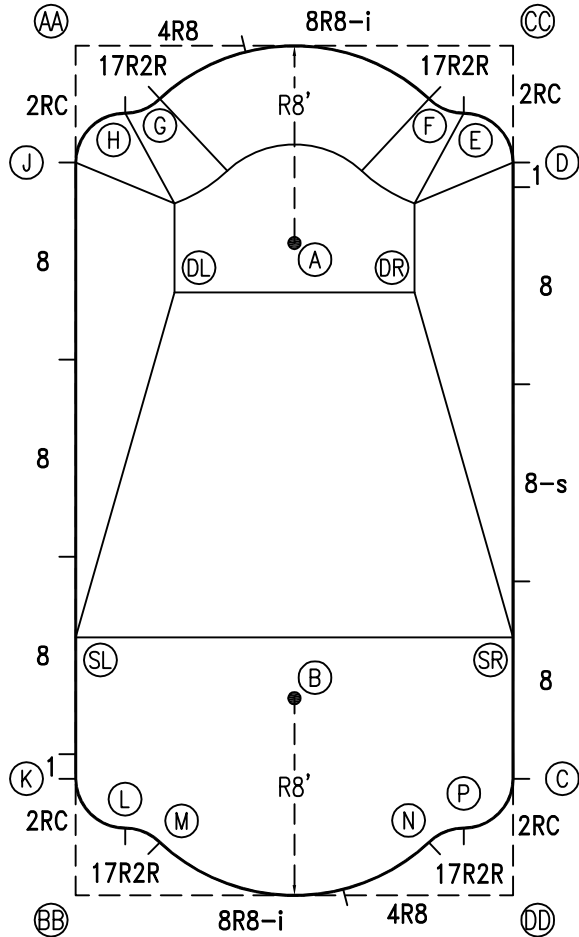

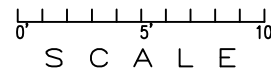
