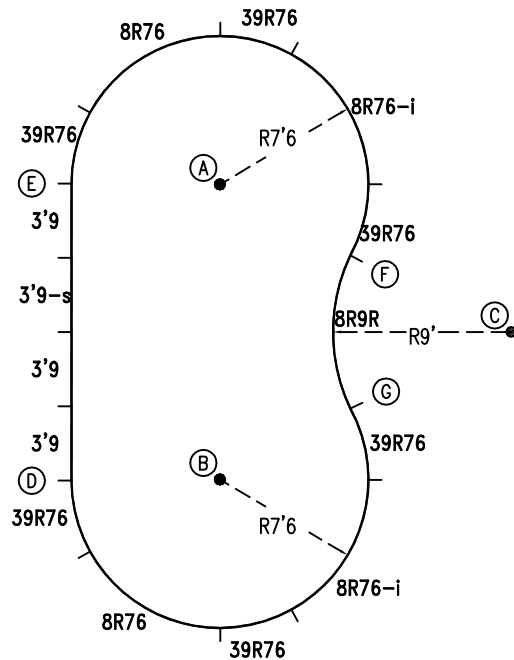

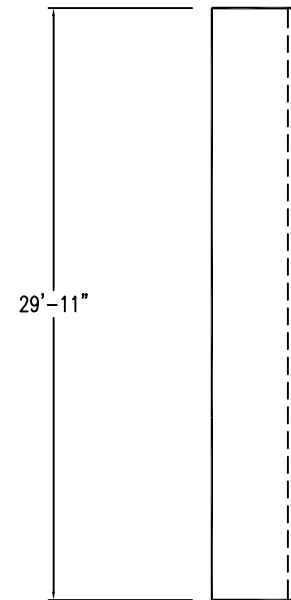

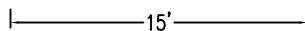


6" WATER LINE

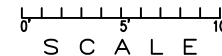

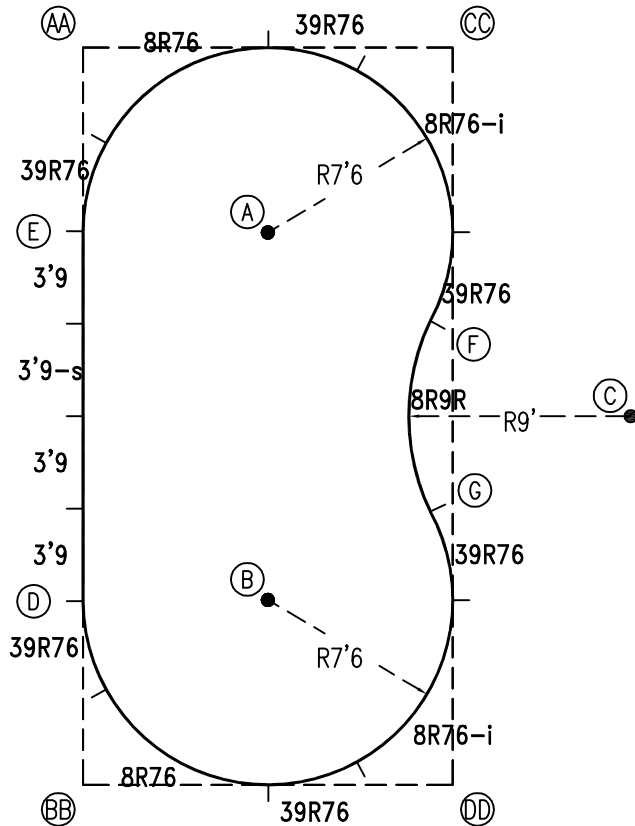
